Village Board Proceedings of December 5, 2018
2019 Budget Hearing & Special Meeting

A Public Hearing was held in the Village of Plain at the Plain Municipal Office Building on December 5, 2018 at 7:00 p.m. The purpose of the meeting was to review the proposed 2019 budgets.

Roll Call: Ray Ring, Village President; Brian Brey; Janet Kraemer; Melissa Kraemer; Robert Neuheisel and Merry Lynn Riek, Trustees. Trustee John Dischler was absent.

Notice of this meeting was posted on November 21, 2018 in the following locations in the Village of Plain: Municipal Office Building; Plain Post Office; and, The Peoples Community Bank. The preliminary budget summary was published in the November 21, 2018 issue of the Home News.

The hearing was called to order at 7:00 p.m. by President Ray Ring.

After review of the information and budgets presented, Melissa Kraemer motioned to adjourn the Public Hearing at 7:01 p.m. Riek seconded. Motion carried.

Melissa Kraemer motioned to adopt the Debt Services Fund Budget of \$184,612.95 as presented. Riek seconded. Motion carried.

Janet Kraemer motioned to adopt the T.I.F. District Fund Budget of \$93,596.80 as presented. Dischler seconded. Motion carried.

Neuheisel motioned to adopt the Capital Improvements Fund Budget of \$64,116.80 as presented. Brey seconded. Motion carried.

Janet Kraemer motioned to adopt the Golf Course Budget of \$46,600.00 as presented. Melissa Kraemer seconded. Motion carried.

Riek motioned to approve the Village tax levy of \$666,202.00. Dischler seconded. Motion carried.

Riek motioned to set the effective payroll date for 2019 wages for Village employees as January 7, 2019. Neuheisel seconded. Motion carried.

Neuheisel motioned to adjourn the Special Board Meeting at 7:06 p.m. Brey seconded. Motion carried.
